Make your gift worth more with Gift Aid

Donations to Sinfonia Cymru are eligible for Gift Aid. This means that we're able to reclaim the tax on your support at no extra cost to you. This is very important to us as it means we can increase the value of your gift by 25%; for example, with Gift Aid a £100 donation will be worth £125, and a £600 gift will be worth £750. To qualify, you need to pay Income Tax or Capital Gains Tax in the UK at least to the value that we (and any other eligible charities you support) will claim on your donation.
